Terms of Rental Agreement for (REG)

It is agreed as follows:

1. Payment Terms

1.1 I agree and guarantee to pay the rent amount of £_____ weekly to Chandler Motor Company Ltd.

1.2 I agree to pay the arranged amount on the payment due date, which is every Monday weekly.

1.3 Payments must be in FULL to Chandler Motor Company Ltd at every arranged payment date.

2. Your responsibilities

2.1 You must look after the vehicle, any accessories and the keys or other locking device for the vehicle. You must always lock the vehicle when you are not using it, and use any security device which is fitted or which we supply. You must always protect the vehicle against weather conditions which could cause damage. You must make sure that you use the correct type of fuel and fluids in the vehicle.

2.2 You must let us know as soon as you become aware of a fault with the vehicle, or if the vehicle is stolen or involved in an accident.

2.3 You must not let anyone work on the vehicle without our permission. Any repairs or servicing is to be carried out by Chandler Motor Company Ltd only.

2.4 You must not carry any object or substance which, because of its condition or smell, may harm the vehicle.

2.5 You must not sell, rent or get rid of the vehicle or any of its parts.

2.6 You must not give or try to give anyone the legal rights to the vehicle or transfer legal ownership.

2.7 You must keep the vehicle clean, tidy and sanitary inside and outside.

2.8 You are responsible for any personal items or property in your vehicle.

3. Charges

3.1 All charges and legal costs for any congestion charge, road-traffic offence or parking offence, or any other offence involving the rental vehicle, including costs from the vehicle being clamped, seized or towed away. You are responsible for paying the appropriate authority or company for any charges and costs if and when they ask for these payments. You will also be responsible for paying our reasonable administration charges for dealing with these matters.

3.2 Any charge for loss or damage resulting from you not keeping to your responsibilities.

3.3 You are liable to pay the excess if the vehicle is involved in an accident.

3.4 You are responsible for all fuel costs.

3.5 You are responsible for Tyres.

4. Conditions of use

4.1 Only you, any driver named on page 1, and anyone we have given written permission to, can drive the vehicle. Anyone driving the vehicle must have a full driving licence which is valid in the European Economic Area for the type of vehicle you are renting.

4.2 You must not rent the vehicle to anyone else.

4.3 You must not use the vehicle (or let someone else use it for):

- Any illegal purposes or in a way which would cause nuisance
- For driving lessons
- To tow or push any vehicle, trailer or other object, without our written permission
- For racing, or to test the vehicle's reliability or speed;
- Off roads or on roads unsuitable for the vehicle
- If the driver has been drinking alcohol or taking drugs
- Outside the United Kingdom, unless we have given you written permission and a Vehicle on Hire Certificate
- If it is loaded beyond the manufacturer's maximum weight recommendations or to carry unsecured loads
- To carry more passengers than the vehicle was manufactured to legally carry
- If the driver does not have a valid operator's licence .
